PC with a minimum of 512MB memory 1GB for Vista Minimum 300MB of free hard disk space

Laser type printer (not deskjet type)

SINGLE PC

For a PC with Windows 2000/XP/VISTA installed.

Please note – If you are running Windows 2000/XP/VISTA you must be logged on the PC as the ADMINISTRATOR or with administrator rights using your user password.

Step 1: Insert the CD into the CDROM drive

Step 2: The install program starts automatically, select INSTALL FORENSIC FILER from the menu.



If install program does not start automatically, select Widows Explorer or My Computer, then right click the mouse on the CDROM drive and select EXPLORE to display the file names contained on the CD.

Select the "Setup.exe" file from the CDROM. To start the Forensic Filer install.

VISTA USERS - When initially running the install , you will be prompted by Vista User Account Control asking if you will "Allow" this program to access your computer. This is standard and normal under Vista for all software installations.

PLEASE NOTE – DO NOT install Sync Server unless instructed



Step 3. The following screen will be displayed.

Step 4: To install Forensic Filer select the 'NEXT' button. Select the 'CANCEL' button to cancel the installation.

After selecting the 'NEXT' button the following screen will display.

5. To install the entire program on a stand alone non-networked PC select the "STANDALONE WORKSTATION" button (default), then select the 'NEXT' button.

To install the program in a networked environment select NETWORK INSTALLATION button and refer to the NETWORK WORKSTATION PC INSTALL document, or select CANCEL' to exit the install process. The following screen will be displayed.
